CSTR EDUCATION ASSISTANCE FUND

Education Assistance is available to CSTR members. The assistance program is funded with proceeds from our open pleasure ride held in June each year. We offering education assistance to all junior members, whether or not they have participated in a CSTR ride, as long as they carry a full course load. Assistance will also be offered to adult CSTR members who are furthering their education and following an accredited course.

RULES AND REGULATIONS

- 1. Recipient must be a current member of CSTR.
- 2. Recipient shall receive \$300.00 per year for college or other further education beyond high school.
- 3. Recipient shall be required to complete a scholarship application each year to receive any additional scholarship awards.
- Additional scholarship awards beyond the first year shall depend upon recipient maintaining passing grades.
- 5. All scholarship awards shall depend upon funds available.
- 6. Completed applications must be mailed by September 1

Election Process

- We will vote electronically.
- In 2024, members who still receive CSTR newsletters by mail will be able to vote by mail.
- Voting will be open from **February 14th to the 21st, 2024**. Mailed in votes must be postmarked no later than **February 21st, 2024**.
- There will be no write-in options on the ballots, as candidates must agree to requirements before being considered.

CSTR DEADLINES

FOR JUNE - SPRING RIDE

CSTR will be providing toilets and a dumpster. The number of toilets required is dependent on the number of participants. CSTR will also be contracting with a caterer and final meal numbers must be given to the caterer 7 days before the start date of the ride. We are bound to the caterer contract.

- Entries and full payment and paperwork must be received 7 days before ride start date.
- Cancellations received before the 7 days entry date will be refunded less a \$30 cancellation fee. Cancellation reasons include illness or injury of horse or rider, or a death in the family. A doctor and/or vet note is required for illness or injury.
- Post entries will be allowed after the 7 days with a \$50 post entry fee but all ride and post entry fees and paperwork must be received no later than 3 days before the ride date.

FOR AUGUST RIDE

CSTR will be providing toilets, a dumpster and horse hay. The number of toilets and amount of horse hay required is dependent on the number of participants. CSTR will also be contracting with a caterer and final meal numbers must be given to the caterer before the start date of the ride. We are bound to the caterer contract.

- Entries and full payment and paperwork must be received 15 days before ride start date.
- Cancellations received before the 15 days entry date will be refunded less a \$50 cancellation fee. Cancellation reasons include illness or injury of horse or rider, or a death in the family. A doctor and/or vet note is required for illness or injury.
- Post entries will be allowed between 15 days and 2 days before the ride date, with a \$50 post entry fee. All post entry forms, ride fees and post entry fees and other paperwork must be received no later than 2 days before the ride date.
